I RESPONDED TO THE LOCATION REGARDING A DISTURBANCE CALL T-441.

I CONTACTED SV/EDWARDS, WHO TOLD ME THE FOLLOWING: HE SAID, WHILE VIDEO TAPING A LA HABRA HEIGHTS CITY COUNCIL MEETING, HE WAS ATTACKED BY SV/PEARCE AND SV/HEINTZ.

SV/EDWARDS SAID WHILE VIDEO TAPING THE AUDIENCE SV/PEARCE GRABBED HIS CAMERA AND PUSHED THE CAMERA TOWARD THE GROUND AND AT THE SAME TIME PUSHED HIM BACKWARDS. SV/EDWARDS SAID HE RECEIVED SCRATCHES ON HIS LEFT FOREARM FROM THE CAMERA BEING PUSHED.

I SAW TWO SMALL SUPERFICIAL SCRATCHES LEFT FOREARM ON SV/EDWARDS  
AP

SV/EDWARDS SAID HE AT NO TIME TOUCHED OR PUSHED SV/PEARCE OR SV/HEINTZ.

I CONTACTED SV/PEARCE, WHO TOLD ME THE FOLLOWING: HE SAID, WHILE ATTENDING

A LA HABRA HEIGHTS CITY COUNCIL MEETING, HE GOT INTO A VERBAL AND PHYSICAL ALTERCATION WITH SUI EDWARDS.

SUI PEARCE SAID SUI EDWARDS WAS VIDEO TAPING THE MEETING, BUT THEN TURNED THE CAMERA TOWARDS HIM AND BEGAN VIDEO TAPING HIM.

SUI PEARCE SAID THE CAMERA WAS WITHIN INCHES OF HIS FACE AND <sup>HE</sup> FELT AS IF ~~HE~~ <sup>HIS</sup> PERSONAL SPACE HAD BEEN INVADED.

SUI PEARCE ADMITTED HE PUSHED THE CAMERA AWAY FROM HIMSELF AND TOWARDS THE GROUND.

SUI PEARCE SAID A HEATED VERBAL ARGUMENT CONTINUED FOR SEVERAL MINUTES BETWEEN HIMSELF AND SUI EDWARDS

SUI PEARCE SAID DURING THE ARGUMENT SUI EDWARDS PUSHED HIM BACKWARDS WITH HIS CAMERA CAUSING PAIN TO HIS LOWER BACK

I CONTACTED SUI HEINTZ, WHO TOLD ME THE FOLLOWING: HE SAID, HE SAW SUI PEARCE AND SUI EDWARDS IN A HEATED VERBAL

AND PHYSICAL ALTERCATION. SUI HEINTZ SAID HE STEPPED BETWEEN SUI PEARCE AND SUI EDWARDS IN ORDER TO SEPERATE THE TWO.

SUI HEINTZ SAID HE PUSHED SUI EDWARDS CAMERA TOWARD THE GROUND BECAUSE THE CAMERA WAS THE ISSUE OF THE ARGUMENT AND BY DOING SO, HE FELT IF THE CAMERA WAS NO LONGER AN ISSUE THE TWO MIGHT STOP ARGUING. SUI HEINTZ SAID SUI EDWARDS THEN PUSHED THE CAMERA INTO HIS BODY CAUSING HIM TO STUMBLE BACKWARDS.

I CONTACTED W/BLAGDEN, WHO TOLD ME HE SAW SUI PEARCE, SUI EDWARDS AND SUI HEINTZ ENGAGED IN A VERBAL AND PHYSICAL ALTERCATION.

W/BLAGDEN SAID HE SAW SUI HEINTZ AND SUI PEARCE PUSH SUI EDWARDS. W/BLAGDEN SAID HE DID NOT SEE SUI EDWARDS ASSAULT SUI HEINTZ OR SUI PEARCE, BUT W/BLAGDEN DID ADMIT HE DID NOT SEE THE ENTIRE ALTERCATION.

I RE-CONTACTED SUI EDWARDS AND HE TOLD ME THAT DURING THE ALTERCATION SUI HEINTZ PUSHED HIS CAMERA TOWARD THE GROUND AND ALSO PUSHED HIM, CAUSING HIM TO STUMBLE BACKWARDS

I SAW THE VIDEO FOOTAGE ON SUI EDWARDS CAMERA AND SAW THAT AN ALTERCATION DID OCCUR, BUT I WAS UNABLE TO CONFIRM ALL PARTIES STATEMENTS.

I SAW VIDEO FROM W/BLAGOV'S CAMERA, AND AGAIN WAS ABLE TO CONFIRM AN ALTERCATION DID OCCUR, BUT WAS UNABLE TO CONFIRM ALL PARTIES STATEMENTS.

SUI EDWARDS PLACED SUI PEARCE AND SUI HEINTZ UNDER CITIZENS ARREST. SUI PEARCE PLACED SUI EDWARDS UNDER CITIZEN ARREST. SEE ATTACHED CITIZENS ARREST FORMS.

ALL PARTIES INVOLVED WERE CITED AND RELEASED IN THE FIELD FOR THE INDICATED CHARGE.

I WAS UNABLE TO LOCATE ANY OTHER WITNESSES.
